A MESSAGE FROM THE HOUSE CORPORATION PRESIDENT



Your House Corporation board and other volunteers have been busy, and I want to thank each of them for their dedication of time

and financial resources. Together we have the opportunity to reposition and restore Eta Chapter to a financially strong position.

In my message here I want to update you on various important activities. I also want to emphasize and stress that as we launch the campaign to restore Eta's financial position and plan for the future, **we neeed you to join us!**

Where are we at on the plan to add an expansion consultant on site? The short answer is we finalized the agreement with the K Δ P Headquarters and they are still in the process of recruiting a consultant. While this is taking longer than initially hoped, we all recognize it's important to have the right consultant and not just a warm body. We've shared a national expansion update in the newsletter and, as you can see, K Δ P is growing and restoring in a number of directions. Our decision to have a dedicated expansion consultant is the right one for us at Illinois. Stay tuned! What's the lease status on the house? As I shared in earlier correspondence, we did finalize a one-semester lease with the men of Triangle Fraternity. Our relationship has gone well thus far. They anticipate completing renovation on their house and moving in for the spring semester. If supply chain and other potential disruptions persist, we do have the option to extend our current agreement. The board is mindful that recolonization may take a year or two. We are currently evaluating opportunities presented by other parties to lease the property following Triangle's term.

What happened with the boiler reserve tank fitting failure? Most of you may have heard, we had a significant failure of a fitting going into the boiler reserve tank. The result was a flooded boiler room overpowering the sump pump system and taking out the boiler. Our property manager worked with the insurance company and, fortunately, we are covered, but it's been a significant project. From the board's perspective, this situation only highlights the reality that we will have significant systems repairs and replacements in the coming years and we are **on track** with the campaign to raise funds over the next few years to, in part, be in a position to replace and upgrade systems as necessary.

Obviously we've got a lot on the plate. We know it will take some time to get the chapter restored and things back on a more normal track. On behalf of the board and the Steering Committee volunteers, thank you for your friendship, brotherhood, and support.

CAMPAIGN UPDATE

We can all agree that having the chapter sputter is inconvenient. The COVID-19 pandemic just exacerbated an already inconvenient and frustrating situation. That said, regardless of the fraternity, chapters sputter and are recolonized every year.

The question for the leadership of $K\Delta P$ was how to manage our resources and position $K\Delta P$ to thrive in the future. The goal of the campaign is simple. Raise \$1.2 million over the next five years.

The funds raised will cover five important needs:

- 1. Three years of operating costs (\$250,000)
- 2. The cost of recolonization over two years (\$100,000)
- 3. Eliminate the current mortgage debt (\$550,000)
- 4. Aesthetic refurbishment of the house (\$100,000)
- 5. Future improvements (\$200,000)

HOW DO WE CHANGE THE OPERATING MODEL?

We are modeling for lower occupancy (25)—this will be comprised of 15 singles and five doubles. We will invariably invest more in operations, including management, maintenance, and cleaning. By removing the mortgage and creating reserves, we can lower our overhead to be more competitive. Finally, as resources permit, we will develop more scholarship endowments to financially help students live in the house.
